NOTICE

In pursuance of the Government approval accorded vide letter No. ASE536/2017/63 dated 19-06-2017, Letter No. ASE.312/2015/141 dated 23-12-2015, Letter No. ASE.537/2013/330 dated 15-02-2014, Letter No. ASE.537/2013/419 dated 13-03-2014 and Letter No. ASE.312/2015/85 dated 16-07-2015 for filling up some vacancies of Post Graduate Teachers in different Provincialised Higher Secondary Schools and pursuant to the Select Lists received from the concerned Inspector of Schools as approved by the District Approval Committees and upon verification of records, the PROVISIONAL SELECT LIST of 338 numbers of candidates have been prepared and published in the official website www.madhyamik.in for general information of concerned candidates. The candidates whose names appeared against vacancies in more than one School, in the PROVISIONAL SELECT LIST may submit their choice of preference for posting on **or before 10-11-2017** directly to the office of the Director of Secondary Education, Assam as per **FORMAT-I** given below, so that appointment order can be issued at an early date.

Further, on scrutiny of records, some anomalies have come to notice. Accordingly, a Reject list of 61 number of candidates has also been prepared, showing the reason for rejection in each case and published in the official website www.madhyamik.in for information of the concerned candidates. The major cause of rejection is that, although *the unreserved vacancies are to be filled up only with that candidates having passed TET with 60% or more marks. But it has come to notice that some candidates who belong to SC, ST, OBC/MOBC category and have passed the TET with less than 60% marks opted for the unreserved vacant posts by giving undertaking earlier to the concerned District level authority.* As such, appointment against such vacancies is hereby kept pending.
