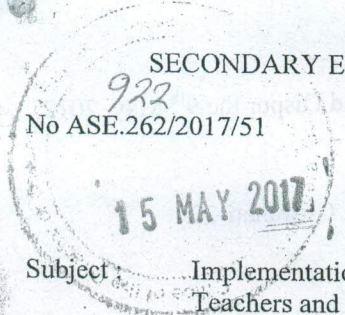

OFFICE MEMORANDUM

Subject: Implementation of the Assam Education (Provincialisation of Services of Teachers and Re-organisation of Educational Institutions) Act, 2017.

Consequent upon notification issued vide No. ASE 262/2017/50 dated 6<sup>th</sup> May, 2017 the Assam Education (Provincialisation of Services of Teachers and Re-organisation of Educational Institutions) Act, 2017 (Assam Act No. XXV of 2017) has come into force (except the provision under section 4 and 8) w.e.f. 5<sup>th</sup> May, 2017, it has been decided to formulate the following time-schedule for effective implementation of the relevant provisions of the Act.

1. The Director of Secondary Education shall publish advertisement calling applications from the eligible venture High Schools/ High Madrassas, Higher Secondary Schools and Junior Colleges (Now Senior Secondary Schools) for consideration of provincialisation of the services of the eligible Teacher/Tutor serving in their institutions by **12.05.2017** as per prescribed format of application as at **Annexure-A** in case of High School/High Madrassa, **Annexure-B** in case of Higher Secondary School and **Annexure-C** in case of Junior College.
2. The application forms as prescribed by the Government shall be made available in the office of the Inspector of Schools by the Director of Secondary Education, Assam on or before **15.05.2017**.
3. The concerned Head of the Venture Educational Institution shall submit the application duly filled in with copy of all required documents to their respective Inspector of Schools with a copy of a Treasury Challan/ Bank draft of Rs.100/- (Rs. One hundred) only being application fee within **05.06.2017**. No application from any venture educational institution shall be received thereafter. The Institutions which fail to submit application along with required documents or submit such applications with incomplete information shall be rejected without assigning any reason whatsoever and such institution shall be treated as not eligible under the purview of this Act.
4. The District Scrutiny Committee as required under section 13(4) of the Act shall be constituted within **25.05.2017**.
5. The District Scrutiny Committee as constituted under section 13(4) of the Act shall then proceed to scrutinize the service records and prepare a list of all eligible employees in respect of each of the eligible venture educational institution, who are eligible to get their services provincialized under the Act and shall submit within **20.07.2017** to the Director of Secondary Education, Assam with detailed information viz. educational qualification, date of birth, date of joining etc.
6. On receipt of the recommendation of the District Scrutiny Committee, the State Level Scrutiny Committee as constituted under section 13(10) of the Act after physical verification and inspection of the venture institutions as may be required, shall submit the final recommendation within **31.08.2017**.
7. The Director of Secondary Education, Assam thereafter shall proceed to submit proposals for creation of posts and provincialisation of the services of the eligible teacher/tutor within **10.09.2017** to the Government in the Secondary Education, Assam.
8. The Government shall proceed to create the required posts and issue notification for provincialisation of services of teacher/tutor immediately.
