

Further, the individual teachers whose educational institutions have already been provincialised as per the Assam Venture Educational Institutions (Provincialisation of Services) Act, 2011 but their services have not been provincialised will have to submit their application for provincialisation of their services under the new Act, 2017 through the concerned Headmaster/Principal but they need not deposit the Treasury Challan/Bank Draft.


Sir,


